# JEFFERSON COUNTY CERTIFICATE OF WATER AND SEWER SERVICE AVAILABILITY

## BUILDING PERMIT - ADVISORY NOTICE

Water and Sewer Availability Certificate - The Jefferson County Building Department will not issue a **building permit** unless this Water and Sewer Certificate is completed. Please note the Health Department or Jefferson County Zoning Department's signature is required.

Private Septic - The Health Department Septic Permit will be required.

Private Well - The Division of Water Resources Well Permit will be required (1313 Sherman - 303-839-3587).

Public Water - The Water District or Agency must complete the appropriate section of the certificate. A letter from the District or Agency stating availability of water will also suffice.

Public Sewer - The Sanitation District or Agency must complete the appropriate section of the certificate. A letter from the District or Agency stating availability of sewer will also suffice.

For the purpose of this form, public sewer and water tap fees do not have to be paid as long as the District certifies that the tap(s) are available.

## REQUIRED HEALTH DEPARTMENT PLAN REVIEW

The following types of facilities must have plans reviewed and approved by the Health Department prior to issuance of a building permit.

- Food service establishments
- Retail food stores
- Licensed day care centers
- Licensed kennels and pet shops
- Mobile home parks
- Camps and campgrounds
- Schools
- Health care facilities
- Drug and alcohol rehabilitation centers
- Penal institutions
- Public or semi-public swimming pools
- Public accommodations (motels, hotels, etc.)
- Any water or sewer system which involves the recycling of water
